Failure to supply the required information will result in delays processing your dealer application.

### Dealer Requirements

The Fuel Moto dealer program is designed to support dealers in the Power sports industry who have an active storefront. At this time if your business does not have a storefront or if your business is not in the Power sports industry we will not be able to accept your application at this time. There is no minimum buy to become a dealer, however if no purchases are made within 12 consecutive months (1 calendar year) you may be required to re-apply. A copy of your sales tax permit and proof of business address is required with this application. Please note, no credit check is being performed with this application.



## Dealer Information

### Payment:

All orders are sent pre-paid. At this time Fuel Moto accepts any major credit card (e.g. VISA, MasterCard, Discover, American Express) that are from the business owners. We will not accept retail credit cards (end customer) for your retail sales. Your company must be sure that funds will be available on the credit card that is being used for the purchase. If the credit card declines for any reason, there will be a fee for each time the card is declined in the amount of \$5.00. This service fee will not be waived for any reason whatsoever. We will accept a business check on the condition that the business owner / check signer is responsible for all NSF checks and any charges which are accrued because of collection fees. There is a \$35.00 fee for all NSF checks. Business checks are required to clear prior to products being shipped.

### Refunds:

All sales are final when shipped. You may only cancel an order prior to the shipment. Canceled orders are subject to a 15% restocking fee.

### Shipping:

For the continental US, most items are available for flat rate shipping of \$24.99, however Fuel Moto offers dealers the option to purchase up to (5) exhaust components for one shipping cost of \$24.99. Orders being shipped to Hawaii, Alaska, and Internationally are charged using the actual freight costs.

### Warranty:

Fuel Moto hand inspects each and every part prior to packaging to ensure that you receive your product in the condition you expect.

1. If you receive a package which appears damaged, please note any damage and create a claim with the carrier. (e.g. FedEx, UPS, USPS)
2. If you find concealed damage (the packaging appears in good condition however the part itself is damaged) please call 920-423-3309 and ask for warranty PRIOR to installing the product so that we can assist in resolving the issue.
3. Once the products are installed or run, Fuel Moto is no longer responsible for cosmetic issues so please ensure the parts are inspected PRIOR to installation.
4. Fuel Moto offers varied length warranties against manufacturer defect of our product. A sales receipt is required to make a warranty claim. Please note that discoloration is not covered and is typically caused by improper tuning.
5. Sound is not a warrantable item however Fuel Moto does offer many different baffle options to ensure that we meet your desired sound levels.
